Sir,

Please find enclosed a copy of Central Vigilance Commission's Circular No. 14/06/09 dated 05.06.2009 and CBI, ACB, New Delhi circular No. 12480 dated 05.10.2009 on the subject cited above regarding displaying of standard notice board in the reception area about the message of the Commission for not giving bribe to any official etc. in the following format, in English, Hindi and as well as in the vernacular language of the area, as below:

"DO NOT PAY BRIBES. IF ANYBODY OF THIS OFFICE ASKS FOR BRIBE OR IF YOU HAVE ANY INFORMATION ON CORRUPTION IN THIS OFFICE OR IF YOU ARE A VICTIM OF CORRUPTION IN THIS OFFICE, YOU CAN COMPLAIN TO THE HEAD OF THIS DEPARTMENT, OR THE CHIEF VIGILANCE OFFICER/THE SUPERINTENDENT OF POLICE, CENTRAL BUREAU OF INVESTIGATION AND THE SECRETARY, CENTRAL VIGILANCE COMMISSION".

"रिश्वत न दें। यदि इस कार्यालय का कोई भी व्यक्ति रिश्वत की मांग करता है या यदि आपके पास इस कार्यालय में भ्रष्टाचार से संबंधित कोई जानकारी है तो आप इस विभाग के प्रमुख या मुख्य सतर्कता अधिकारी/पुलिस अधीक्षक, केन्द्रीय जांच ब्यूरो तथा सचिव, केन्द्रीय सतर्कता आयोग को अपनी शिकायत कर सकते हैं।"

In addition to above message, the designation, complete address, telephone/fax nos. and E-mail address of the Head of the Department, Chief Vigilance Officer and SP, CBI is also to be displayed. The details about the concerned SP, CBI, ACB of the area may be obtained for incorporating the same in the display board.

The revised guidelines of Central Vigilance Commission may kindly be implemented at the earliest under intimation to the Chief Vigilance Officer so that a compliance report in the matter may be sent to the Central Vigilance Commission.
